





About College

What could be more divine than receiving education in God's own land! Village Panarasa opens the corridor to the valley of Gods, the much-famed Kullu Valley Situated at the right bank of the river Beas, 25 kilometers to the south of Kullu town and 45 kms to the north of Mandi on NH-21. Govt. College Panarsa was established in the year 2015 amid all embracing orchards, green pines and wooded environs. A hundred-year-old Govt. Senior Secondary Panarsa School is in its close vicinity with spectacular Himalayan range and the nearby legendary Parashar Lake. It is an ideal place for a higher learning educational institution. It is like a dream come true to the people of the surrounding areas to have higher education at their doorstep.

At present college offers a graduate program in Arts and Commerce streams. Initially, the college was started in the makeshift accommodation in the premises of the Govt. School. The school authority has been providing all assistance to the college including a huge playground which is open to college students also. The construction work of the new building of college has already started and in near future, the college will have its own campus. The first ever Parent Teacher Association (PTA) has also been constituted so as parents may be made aware of the schemes for students being implemented and various other departmental activities undertaken from time to time: NSS unit of the college has been functional since 2017.

At present the college has seven classrooms. In 2021, out of seven class rooms, two have been transformed into smart classrooms and one room converted into full-fledged library with new furniture and books worth 2 lakhs. Beside it a fully equipped music room with newly added musical instruments exists in college. Raised platforms have been built in all the classrooms. Sports equipment, tools and gears have also been added in the present year.

Cultural fest "Sargam" is organized every year to showcase the cultural activities of the students. The college magazine is another useful platform to hone the writing skills of the budding writers. In fact, the college aims to provide quality education to inculcate excellence among the students so that they can keep in pace with the fast-evolving competition and challenges which they are going to face in their lives. CONDUCT AND DISCIPLINE

- Ragging is strictly banned in the college. There shall be no ragging in and around the college.
- Ragging means any type of physical or mental torture, done by any individual or group, either by words or by conduct, which gives an apprehension in the mind of a person that he cannot pursue his studies free from any mental disturbance/torture created thereby.
- Following nefarious activities will be considered gross misconduct and can lead to fine or suspension/expulsion:
 - a. Writing obscenities/ dirty words on black boards, walls or furniture.
 - b. Aimlessly loitering in the corridors, raising noise or attempts to disturb classes.
 - c. Smoking or taking Drugs/Alcohol etc. in the campus.
 - d. Any attempt to damage the furniture or other property of the campus.
 - e. Pasting posters on the walls or notices on the Notice Board without Principal's permission.
 - f. Misbehaving with the college staff.
 - g. Using mobile phones in the class room and playing music on the cell phones in the campus.
 - h. Bringing outsiders, miscreants or anti social elements in the campus.
- Students who participate in sports or other extra-curricular activities/educational tours must produce written permission from their parents/guardians.
- Every student must carry with his/her identity card which is issued to him/her when he/she joins the college. He/she must produce the identity card whenever demanded.
- Parents/Guardians are requested to remain in touch with the college Principal and the concerned teachers regarding the progress of their wards.

Choice Based Credit System: Annual system from 2018-19

Implementing the guidelines of RUSA HP Govt, has switched over to annual system of examination from session 2018-19 onwards. The academic council of Himachal Pradesh scrapped the semester system and started annual system under the RUSA from 2018 onwards.

The CBCS provides opportunity for the students to choose courses from the prescribed courses comprising core, elective/minor or skill-based courses. The courses can be evaluated following the grading system, which is considered to be better than the conventional marks system. Therefore, it is necessary to introduce uniform grading system in the entire higher education in India. This will benefit the students to move across institutions within India to begin with and across countries. The uniform grading system will also enable potential employers in assessing the performance of the candidates. In order to bring uniformity in evaluation system and computation of the Cumulative Grade Point Average (CGPA) based on student's performance in examinations, the UGC has formulated the guidelines to be followed.

Outline of choice-based credit system

1. Core Course:

A course, which should compulsorily be studied by a candidate as a core requirement termed as a Core course.

2. Elective Course:

Generally, a course which can be chosen from a pool of courses and which may be very specific or specialized or advanced or supportive to the discipline subject of study or which provides an extended scope or which enables an exposure to some other discipline/subject/domain or nurtures the candidate's proficiency/skill is called an Elective Course.

2.1 Discipline Specific Elective (DSE) Course (2 Each for regular courses):

Elective courses may be offered by the main discipline/ subject of study is referred to as Discipline Specific Elective. The University/Institute may also offer discipline related Elective courses of interdisciplinary nature (to be offered by main discipline/subject of study).

2.2 Dissertation/Project:

An elective course designed to acquire special advanced knowledge, such as supplement study/support study to a project work, and a candidate studies such a course on his own with an advisory support by a teacher/faculty member is called dissertation /project.

2.3 Generic Elective (GE) Course:

An elective course chosen generally from an unrelated discipline/subject, with an intention to seek exposure is called a Generic Elective.

P.S.: A core course offered in a discipline/subject may be treated as an elective by other discipline/subject and vice-versa and such electives may also be referred to as Generic Elective.

3. Ability Enhancement Courses (AEC)/Competency Improvement Courses/ Skill Development Courses/Foundation Course:

The Ability Enhancement (AE) Courses may be of two kinds: AE Compulsory Course (AECC) and AE Elective Course (AEEC) "AECC courses are the courses based upon the content that leads to Knowledge enhancement. They are: (1) Environmental Science, (ii) English/MIL Communication) are mandatory for all disciplines. AEEC courses are value-based and/or skill-based and are aimed at providing hands-on-training, competencies, skills, etc.

3.1 Ability Enhancement Compulsory Course (AECC):

Environmental Science, English Communication/MIL Communication.

3.2 Skill Enhancement Courses (SEC) (Minimum 4):

These courses may be chosen from a pool of courses designed to provide value-based and/or skill-based instruction.

Course structure:

There are total of four core courses (DSC-1) In main subject and four core courses (DSC-2) in second subject that students are required to take across first two years. In addition to core courses in main subject student will choose two discipline specific elective (DSE) from main subject and two DSE from second subject of study in third year. Skill enhancement courses (SEC) course are offered in second and third year and four such courses have to be selected from main subject. Student of BA programme will select any two generic elective courses (GE) from unrelated discipline/subject other than main subject and second subject of study.

Contact Hours:

Each course has 5 lectures and 1 tutorial per week in case of DSC, DSE and GE courses 4 lectures and 2 practical/tutorial per week in SEC courses.

Course Duration

This is a three-year course. The degree will be awarded when candidate clears all courses within a maximum Period of 5 years from the date of admission to this course.

NOTE: A candidate failing in either one or two subjects/paper will be given compartment in that subject/paper and will be eligible for promotion to next class. Two chances (one at supplementary stage and one at annual exam stage will be given to clear the compartment candidate failing in three or more subjects/paper will be treated as failed in that year and will be required to repeat the entire year.

Following four subjects are Essential:

1. Compulsory English (Language Core)
2. Compulsory Hindi (Language Core)
3. AECC Environment Studies
4. AECC English/Hindi (One of them)

Eligibility

First Year

1. A candidate should pass in the Senior Secondary (+2) Examination (Academic Stream) conducted by H.P. Board of School Education or an examination accepted as equivalent there to by the various bodies of the University.
2. Provided that the candidates who have passed the qualifying examination with commerce stream shall be given preference in admission to B.Com. Programme.
3. A candidate passed 10+2 with one subject as mathematics or economic is also eligible to take admission in Commerce Stream.
4. Provided that the candidates who have passed qualifying examination with arts stream/humanities shall be given preference in admission to BA programme.
5. The Candidate in 1st Year of UG Course will be admitted on the merit basis (percentage of marks/grade obtained in 10+2 examination).
6. The student with compartment case is not eligible for admission.

Second Year / Third Year

A candidate must have appeared/passed in the Previous Year University Examinations. Other Conditions are as per University Norms.

Age Limit

Maximum age limit for admission to B.A./B. Com courses is 23 for male candidates who belong to the general category and 25 years for girls as on 1st July 2024. A relaxation of 3 years is applicable to candidates belonging to SC/ ST category. The Vice Chancellor may permit age relaxation up to maximum of 6 months.

Admission Process

- 1.The candidate seeking admission in the college has to apply online at gcpanarsa.edu.in
- 2.The students can approach the College Guidance and Counselling Committee in case they find any difficulty in filling up of the admission form during the college hours.
- 3.The fresh applicant needs to register on the online admission portal and once registered, will use the created **User Id** and **Password** to fill up the application. Then the student will have to pay the prospectus fee.
- 4.Once submitted, the application will be verified by the admission committee.
- 5.The merit lists will be displayed as per schedule mentioned in the prospectus.
- 6.Applicants seeking admission in first year are required to present themselves against the counselling committee as per the scheduled in the merit list.
- 7.After the approval of counselling applicants are advised to deposit their fee online by using UPIs (BHIM/Google Pay/ Phone Pay/ Paytm)/Mobile/Internet Banking/Debit Card.

Note: 1. Only online mode of application and fee submission is accepted.

2. The students of BA/B.Com 2nd and 3rd Year must login to the admission portal with their last year's User Id and Password. They should not register again or create a New Id and Password.

Documents Required to Be Uploaded with the Form:

- 1.Matriculation certificate for Date of Birth.
- 2.10+2 marks sheet.
- 3.H.P. Domicile certificate for girl students (for exemption in tuition fee).
- 4.Minimum 40% disability certificate, sports/cultural quota and category certificate in case of students seeking admission against these seats.
- 5.Original character certificate from Head of the Institution last attended. In case of private candidates, the character certificate must have been issued by a Gazetted officer/ Panchayat Pradhan/ Ward Counsellor but not older than 6 months from the day of submission of admission form.
- 6.For seat against the 'single girl child category' an Affidavit proclaiming the same from the parents is to be submitted with the admission form.
- 7.A student seeking admission from Board/University other than H.P. will have to upload the copy of migration certificate and the original certificate has to be submitted at the time of counselling.

8. Certificate of SC/ ST (if applicable) from Magistrate Class-1 (Authorized Signatory)
9. Any gap (latest) in the academic career of the applicant must be supported by a documentary evidence/ affidavit as proof of his/ her activities during the period of gap.

Students Course wise Continuous Comprehensive Assessment (CCA) and Evaluation

All courses involve an evaluation system of students that has the following components:

1. **Term End Examination:** It is of three-hour duration covering whole syllabus of the course and counts for 70% in theory for Arts and Commerce where practical is not involved. For the subjects/courses where practical is involved it is 50% in theory, 20% in practical and 30% in CCA/IA.
2. **Continuous Comprehensive assessment (CCA): For determining CCA following procedure is applicable:**
 - 5 marks for attendance.
 - 15 marks for house test/mid term to be taken on completion of 75% of syllabus.
 - 10 marks for assignments, tutorials, general behaviour of student
 - Total marks of CCA: 30

Classroom Attendance: Each student will have to attend a minimum of 75% Lectures/ Tutorials/ Practical's. A student having less than 75% attendance will not be allowed to appear in the Term End Examination.

1. Provided that those having between 74% and 65% attendance will apply for exemption in a prescribed form accompanied by clear reason(s) for absence to the authorized functionaries.
2. Provided that those having between 64% and 50% attendance will apply for exemption in a prescribed form accompanied by a Medical Certificate from a Government Hospital.
3. Provided that exemption from 75% attendance will be given to those participating in prescribed co-curricular activities (e.g., NCC, NSS, Youth Festivals, Sports etc.) to the extent of 25% (making the necessary attendance as 50% in these cases). However, the claim for this exemption should be supported by authenticated certificate from the concerned college authorities.
4. Provided further that those getting the exemptions, except for those getting exemptions for co-curricular activities will not be entitled for getting the CCA marks for classroom attendance as given below.

Classroom Attendance Incentive:

Those having greater than 75% attendance (for those participating in Co-curricular activities, 25% will be added to percent attendance) will be awarded CCA marks as follows:

- > 75% but < 80% 1 marks
- > 80% but < 85% 2 marks
- > 85% but < 90% 3 marks
- >90% but < 95% 4 marks
- > 95% 5 marks

The registration for the Term End Examination will be done at the time of the enrolment for the course. The fee for the Term End Examination will also be collected at that time as decided by the university from time to time.

Leave Rules and Fine

- A student can proceed on leave with prior permission of the Principal but the application should also be signed by the parents of the student and duly recommended by the tutor.
- A tutor can recommend leave up to maximum of five days and leave for longer duration will be sanctioned by the Principal.
- Leave on account of illness if it is for more than three days must be accompanied by Medical Certificate.
- Student's participation in various inter college games or other competitions including youth festival, tour etc. will have to get their leave sanctioned by the Principal with prior recommendation of their incharges concerned before their departure.
- The name of a student will be struck off from the college roll in case he/she dose not attend continuous classes for workshop days.
- The students can seek re-admission twice during the session. First re-admission will be allowed within three days after the name is struck off after paying a fine of 100/- and a fine of 200/- will be charged for the second re-admission within 10 days after the name is struck off from the rolls.

Identity Card:

- Identity card is the most important document of the college student, because it is the only identification for anyone to establish that one is a student of the college.
- Any transaction between students and college is entertained only after production of Identity card. If a student has to deal with any kind of work related to examination, library, collection/inspection of documents, and one has to produce one's Identity card in order to establish one's identity.

- Students are not permitted to replace the photograph pasted on the Identity card for any reason whatsoever.
- If Identity card is lost, one has to file an F.I.R. in order to get a duplicate Identity card issued.
- In event of inspection of Identity card during surprise check or for any other reason, if the student is unable to produce the Identity card he/she will be handed over to the police or as the situation may demand. Students without Identity card are deemed as outsiders.
- In case, the Identity card gets misplaced, misused by anti-social elements the student concerned shall be held responsible for his/her deeds. It is the personal responsibility of the student to keep his/her identity card in safe custody.
- All the students are directed to collect their identity cards and complete the formalities related to their identity cards within one week of admission.

Facilities and Co-curricular Activities in the College:

CSCA:

The CSCA (College Students Cultural Association) is formed by the College every year according to Himachal Pradesh University guidelines on the basis of merit based nomination.

OSA (Old Student Association)

An Old Students' Association is formed in our college with effect from session 2024-25. This association will serve as a platform to connect with former students and engage new students in the college's development. By harnessing the experiences of old students and the energy of new students, the association can contribute towards the overall growth of the college. It's an initiative to foster a strong alumni network and promote collaboration between past and current students.

Clubs and Societies:

The college has various clubs and societies to inculcate community participation among the students. The students can join one of the following clubs/societies according to his/her interest in the field of choice:

- Eco Club
- Red Ribbon Club
- Literary Society
- Humanities Society
- Commerce Society

NSS (National Service Scheme):

NSS is a very important part of the activities of any educational institute. It helps in developing the spirit of service for the community. The College has a full unit of around 100 NSS volunteers who engage in campus beautification, cleanliness and other services for the community. Various awareness drives are undertaken by the NSS unit.

Rovers & Rangers:

The College has recently established a well organized units of Rovers & Rangers.

Sports:

The College provides facilities to sportsmen who wish to make a mark in games. The discipline in which the college plans to prepare teams for University Championships are: Athletics and Volley-Ball. The college provides various incentives for the students participating in competitions held at University/State/Zonal/National Level. A committee of teachers will decide the formation of teams to represent the college in different tournaments.

The college also provides guidance to students for participation in various competitions. These items are Music (Vocal), Debates, Declamation, Quiz, Poetic Symposium, Painting, Dance, Poster Making and Rangoli etc.

Career Guidance and Placement Cell:

This cell helps students by providing guidance about career options and information about job placements through various Govt. and private agencies. It arranges lectures by experts and concerned officials for selection of better & suitable career options.

Annual Prize Distribution Function:

Annul prize distribution function is an occasion to award students who excel in the fields of Academics, Sports, cultural, NSS and other activities. The rules for the prizes will be notified one month prior to the celebration.

PTA (Parent-Teachers Association):

There is a Parent-Teachers Association in the college with the objective to have participation of parents for development of the institution. The executive committee of PTA is elected during the month of August every year. There is a General Body of PTA comprising:

- Parents or guardians
- Colleges Teachers
- The principal of the college as the patron

College Magazine: The College publishes its magazine "*Arjikiya*" annually which provides a forum to the students with a flair for writing.

Educational/Study Tours:

Educational/Study tours are organized so that the students do not remain confined to their curriculum and can extend outside the boundaries of the classroom and academics. The NSS volunteers who are regular in their attendance and have good conduct will be eligible for the tour. Students will have to produce a written permission from their parents for joining such tours. No tour can be organized without accompanying of any teacher and prior permission of the college administration.

College Library

The college library is having about 1500 books in various subjects, magazines, and newspapers. Recently our college has registered in NDLI (National Digital Library of India). National Digital Library of India (NDLI) is a virtual repository of learning resources which is not just a repository with search/browse facilities but provides a host of services containing textbooks, articles, videos, audio books, lectures, simulations, fiction and all other kinds of learning media for the learners/user's community. Students can approach this facility with the help of library staff.

All the students are required to adhere to the following Library rules strictly:

- All the students on the rolls of the College shall be eligible to become members of the College library.
- Every student is entitled to borrow two books for a period of 15 days from the library.
- The borrower shall be solely responsible for the safety/preservation of the books drawn by him/her.
- A fine of Rs. 1/- per day per book will be charged beyond due date of, return of the book.
- In case a book is found mutilated, torn, defaced or misplaced, the actual cost of the book plus 20% of the original cost will be charged from the student.
- Reference books are to be consulted in the library itself after obtaining permission from the Librarian.
- The College also operates a book bank from which text books are loaned to poor students of all categories on payment of a nominal security, (i.e., actual cost plus 20% and maintenance charge of Rs. 2/- per book).

Note: Students can get their library security refunded within one year after leaving the College; otherwise, the security stands forfeited.

RAGGING: A PUNISHABLE OFFENCE

THE HIMACHAL PRADESH EDUCATIONAL INSTITUTIONS (PROHIBITION OF RAGGING) ACT, 2009

PROHIBITION OF RAGGING) ACT, 2009 defines "ragging" means any act, conduct or practice by which dominant power of senior students, former students or outsiders, is brought to bear on students freshly enrolled or students who are in any way considered junior by other students and includes individual or collective acts or practices which-

1. Involve physical or psychological assault or threat or use of force or wrongful confinement or restraint; or
2. Violate the status, dignity and honour of such students; or
3. Expose students to ridicule and contempt and affect their self-esteem; or
4. Entail verbal abuse and aggression, indecent gestures and obscene behaviour.

A student who commits the offence of ragging shall be punishable with imprisonment for a term which may extend to three years or shall also be liable to a fine which may extend to Rs. 50,000 or both. If a student is convicted of the charges of committing, abetting, participating or propagating ragging, he shall be dismissed from the college and such student will not get admission in other college for a period of three years from the date of his dismissal from the college.
